Midwest SPR is committed to presenting the broadest possible range of high-quality work at the **Midwest SPR 2021 Virtual Scientific Meeting**. All submitters should go to the [Midwest SPR Abstract Submission Site](#), create a new account, and follow all instructions to submit an abstract.

Scientific Content

- Historically, abstracts accepted for presentation are hypothesis-driven new work.
- Abstracts rarely accepted for presentation include open-label drug trials, single case reports, highly speculative accounts of clinical experience, and op-ed accounts of personal experience.
- Interim results from an ongoing clinical trial will not be accepted for presentation unless the study has been prematurely closed for efficacy, lack of efficacy, or issues of safety.
- If the abstract is selected, the presentation must include the methods used for study and any other information relevant to research.
- There is no limit on the number of abstracts submitted by each author, but the submission of multiple, similar abstracts from the same investigator(s) or laboratory is strongly discouraged.

General Submission Policies

- Character count is 2,600—includes spaces and title; excludes author's name, institution and upload of tables and images.
- A maximum of four images or tables may be uploaded with the abstract.
- A submission fee of \$60 is required for each abstract submitted, payable by credit card only.
- Submitter does not need to be a member of Midwest SPR to submit an abstract for the Midwest SPR 2021 Virtual Scientific Meeting.
- The submitting author verifies upon submission that all authors have agreed to the submission of the abstract.
- Abstracts submitted or presented to other societies or national meetings cannot be submitted for consideration unless additional data has been added.
- Research published in manuscript form prior to the submission of the abstract **should not be submitted**. If data contained in the abstract is published after submission of the abstract, the Midwest SPR Program Office must be notified regardless of timing as soon as publication is recognized. A member of the program committee will make a determination concerning presentation. Abstracts should not be submitted if there is knowledge of an upcoming publication prior to the annual meeting or submission deadline.

- **Conflict of Interest/ Disclosure:** Work submitted for presentation must include an acknowledgment of funding sources of commercial nature and/or consulting or holding of significant equity in a company that could be affected by the results of the study. Even if indicated elsewhere in the abstract, this must appear as the last sentence of the abstract and read "funded by..." and/or "equity in..." if pertinent.
- Any **animal studies** must conform with the "Guiding Principles in the Care and Use of Animals" of the American Physiological Society and any human experimentation has been conducted according to a protocol approved by the institutional committee on ethics of human investigation. And, if no such committee exists, it must conform with the principles of the Declaration of Helsinki of the World Medical Association (Clinical Research 14: 193, 1966).

How to Submit an Abstract

Follow the step-by-step process below for submitting an abstract. To save time, gather all information needed before starting. Create an account or log in at the [Midwest SPR Abstract Submission](#) site. This is a new submission platform for 2021.

Task 1 – Abstract

- Select a Category—Basic Science, Clinical Investigation, or Health Services Research.
- **Poster Consideration** – check the box if you only want to be considered for a poster only, or for both poster and oral presentations.

- Provide information in the boxes labeled Background, Objectives, Design/Methods, Results, and Conclusion, then press **Continue**.
- Remember, even if indicated elsewhere in the abstract, the last sentence of the abstract must specify "funded by..." and/or "equity in..." if pertinent.

Task 2 – Tables and Images

- You may upload a maximum total of four images in any of the following formats: gif, png, tiff, tif, jpg, or jpeg. No pdf. Tables should be uploaded as an image.
- Add a Title and Caption for the image, if desired.
- If you choose not to upload images, you can click on the **Opt Out** box.
- Press **Continue** when all images are uploaded.

Task 3 – Keywords

- Enter up to three keywords in order of importance, then press **Continue**.

Add Author


- To add an author, type the author's first name, last name, and email address, then Click 'Add Author.'
- If the author is already in the database, the author account will be added. If not, a new account will be created.
- Note: to avoid creating duplicate accounts, submitting authors should **check with all co-authors to confirm the preferred email addresses to use**. Many institutions have multiple variations for their emails: confirming emails in advance streamlines many future steps.
- The submitter can edit an author's profile to add the basic information needed to proceed (name, email, position, institution/company/organization, degree(s), role, and professional status).
- Submitter should invite the co-author(s) to complete/edit their author profile. The task will not show as complete until all authors have completed their profiles.
- Updates made to the **author profile** will carry over to other abstracts from the same submitter. Authors do not have to create an account to make these changes.

- The invite button will send an email to the co-author(s) as shown below. The authors can click on the link to resolve the two tasks listed. Submitters will receive emails from the system when authors complete the tasks. Note that some emails may go into spam filters, so if you don't hear from your colleagues, remind them to check their spam folder.
- **New this year:** Co-authors can preview the abstract when they access the system to complete these tasks but edits to the abstract can only be made by the submitting author.

Task 5 – Conflict of Interest

- The presenting author is required to submit a Conflict of Interest Disclosure. To ensure that presentations do not have commercial influence/promotional bias, the presenting author must demonstrate that all financial relationships with commercial interests are disclosed to the learners prior to the beginning of the educational activity. The learners must also be informed if no relevant financial relationships exist.
- If the presenting author is not the submitting author, the submitter should use the “Invite” button below the presenting author’s name to create an automatic email to that speaker inviting them to complete the disclosure form.

Task 6 – Payment

- Click the link to complete the payment process. The non-refundable abstract submission fee is \$60, payable by credit card only. Payment is made via PayPal.

Following completion of all tasks, press **Continue & Preview**.

- Before you submit your abstract, you can preview and edit all the information entered in each step of the submission process. A green check mark displays tasks that are successfully completed, a red X marks those that are incomplete. You can click on the Task List at any point to review the information in each section.
- The abstract can be previewed at any time, even if some tasks are incomplete.
- **Submit your abstract:** When all tasks, including Payment, are complete, you can **submit your abstract**. Remember to submit by the **deadline: Aug. 12, 2021, 11:59 pm CT**.

Editing an Abstract

- Prior to submitting - **Abstract Status: Active:** Click on the abstract to open the file and see the status of all tasks. Make edits and save.
- After submitting – **Abstract Status: Complete (Submitted xx/xx/xxx):** Make sure you save any tasks you update them.

Notification and Abstract Presentations

Presentation formats (oral presentation or poster) are determined in September by the MSPR Program Committee.

- Oral presentations are 15-minutes (10 minute/presentation; 5 minute/discussion).
- E-posters will be available in the virtual meeting platform and presenters can interact with attendees via chat. All e-posters will have a three-minute audio recording describing the research and conclusions.
- Detailed instructions for the preparation of slides and posters, as well as scheduling notices, will be provided to the contact author with the presentation notification on Sept. 3, 2021.

Publication of Abstracts

All abstracts, if accepted for presentation, will be available online.

Awards

Midwest SPR announces several awards during the meeting, based on abstracts accepted for presentation. There is no separate award submission process. Visit the [MSPR website](#) for more information.
